**PENSION FUND MEMBERS WITH UNCLAIMED BENEFITS AS AT 31 MARCH 2019**

1. The above matter refers.
2. The Insurance and Pensions Commission requests each fund to submit a schedule of members with unclaimed benefits and the amounts owing to each of them as at 31 March 2019. The schedules must be submitted to the Commission by 15 May 2019.
3. Going forward, the above information will be required as part of the quarterly returns showing movement on the position of unclaimed benefits figures in terms of membership and monetary values.
4. The information should be submitted in the format shown below. The figures on the schedule should be consistent with the summarized breakdown of membership by class and the unclaimed benefits reported under liabilities on the Statement of Financial Position at the end of the respective quarter.
