

## SEMINAR ON FINANCIAL REPORTING FOR INSURERS

- The Insurance and Pensions Commission (IPEC) in conjunction with the Institute of Chartered Accountants of Zimbabwe (ICAZ) is holding a seminar on "Financial Reporting for Insurers" on the 8<sup>th</sup> of May 2012.
- 2. All Financial Directors, Finance Managers, or those involved in the preparation of financial statements for insurers notwithstanding the various titles used in reference to these positions and Compliance Officers are required to attend the seminar.
- 3. We are also inviting other interested parties such as brokers, auditors, analysts e.t.c. to attend the seminar.
- 4. This seminar is held against a background of the need to address various disparities that are evident in accounting, presentation and disclosure by insurance entities in Zimbabwe. This has resulted in the questioning of the fair presentation of the insurers' financial reports thus rendering their objective comparison difficult.
- 5. One of the main reasons for the diverging financial reporting is lack of adequate comprehension by preparers of financial statements, of the International Financial Reporting Standard ("IFRS") 4.
- 6. The seminar is also meant to clarify the generally accepted accounting practices in accounting, presentation and disclosure by insurers within the International Financial

Reporting Standards framework and global regulations, which include the requirements of Solvency II.

- 7. The seminar will cover the following issues:
  - a) accounting for treatment in changes in policyholder liabilities
  - b) reserving,
  - c) premium accounting,
  - d) presentation and disclosure requirements of insurers with the IFRS
  - e) presentations by IPEC
